I agree that Delta Western, Inc., dba Delta Western Petroleum will not be liable or responsible for any inadequate supply of fuel in the event of sudden changes in consumption without reasonable notice to Delta Western, Inc., dba Delta Western Petroleum or due to leaks or other loss of fuels not caused by negligence on the part of Delta Western, Inc., dba Delta Western Petroleum. I understand if I utilize wood stoves or other sources of heat other than oil, an interruption of such use (i.e. mid-winter vacation and/or discontinued use of wood or supplemental heating source) will result in an increase in my oil consumption. I agree to give written notice to Delta Western, Inc., dba Delta Western Petroleum prior to any interruption.

In the event I wish to terminate my Delta Western, Inc., dba Delta Western Petroleum account, I agree to give Delta Western, Inc., dba Delta Western Petroleum written notice. If notice is given by mail, it will be sent Certified or Registered Mail only. Notice of any cancellation shall only be effective when received by Delta Western, Inc., dba Delta Western Petroleum as determined by the return mail receipt. I agree to pay within ten (10) days of invoice, for all fuel delivered prior or on the same day as the notice of cancellation was received by Delta Western, Inc., dba Delta Western Petroleum.

I further agree Delta Western, Inc., dba Delta Western Petroleum will not be liable for non-delivery of fuel for any reason beyond its control, including without limitation (product shortage, strikes, work stoppages/slowdowns & adverse weather conditions). In addition if Delta Western, Inc., dba Delta Western Petroleum halts delivery because of my failure to notify Delta Western, Inc., dba Delta Western Petroleum of the times and dates the dwelling will be vacant for any period of time, or of any factor that will alter normal fuel usage and/or failure to make payments on the account or failure to comply with any other agreement with Delta Western, Inc., dba Delta Western Petroleum Legal Fees and costs associated with collection are for buyer. In no event shall Delta Western, Inc., dba Delta Western Petroleum be liable for indirect, special, or consequential damages on account for the non-delivery of fuel.
